ACESF Assists Families of TDCJ Staff Killed By Tornado

On April 22, 2020 two employees with the Texas Department of Criminal Justice died when a tornado struck near Onalaska in Polk County. Taylor Holbert (29), an Industrial Specialist with the Manufacturing, Agribusiness and Logistics Division and Brooke Ivey (27), a Contract Specialist with the Business and Finance Division were killed by the deadly weather event that caused extensive damage and left dozens of others injured and homeless. Upon learning of this tragedy, the ACESF Board voted to provide monetary assistance to the Holbert and Ivey families.
